

Enprise builds North American base

Auckland. 21 August 2015. Enprise (NZAX: ENS) has entered into a business agreement with a specialist ERP provider to represent Enprise in the US and Canada as 'Enprise North America' in a move that brings additional services and support to Enprise Software's North American reseller channel.

"It also has appeal to our MYOB EXO and MYOB Advanced customers," he says.

"We are now extending development to reach out to these customer bases, adding them to our current SAP B1 user market."
